Health License Fee: Current Rate *Jersey City Businesses need not apply, you must include a copy of your current license with this signed contract.*
Fire License Fee: Current Rate (If using an “open flame” unit, propane, charcoal or wood)
Electrical – (2) 110v lines \$150.00 **Electrical** (1) 220v line \$200.00 **Special Outlet Socket** \$75.00
Trash Removal: \$150.00 (Food Vendors)
Rent: Food Vendors: \$1,100.00 (\$220 per day) Merchant Vendors: \$550.00 (\$110 per day)

Food Vendors:

If you are using an open flame unit, propane charcoal or wood, the **Jersey City Fire Department** requires a fire license. You must obtain your open flame permit from the JC Fire Department; the Fee is **\$125.00 per open flame unit.** (*Electrical Appliances do NOT count*). Obtain your fire permit at JC Fire Prevention Headquarters at 465 Marin Blvd., Jersey City, 201-547-4255.

The City of Jersey City also requires a **Health License** if you are selling any type of edible product. You must obtain your Jersey City Health License; the Fee is **\$50.00.** *If you have a Jersey City Health License, please provide a copy when submitting your Contract and payment.* Obtain your health license at JC Department of Health, 1 Jackson Square, Jersey City, 201-547-6800.

Electrical Requirements:

You will be given access to (2) 110volt outlets – 15 amps each. **Be sure to bring adequate outdoor extension cords to run to the drop boxes, which can be as much as 50 feet away.** Please notify us of any special power needs you may have. Additional Fee applies for SPECIAL OUTLET REQUIREMENTS. PLEASE CONTACT US AHEAD OF TIME.
Food Trucks: Electrical hook-up is available only for overhead lighting. You must provide your own generator for your refrigeration and cooking equipment.
